AND UPON the Application dated 21 January 2016 of the Defendants subject to the penal order AND the Application dated 12 February 2016 of the Claimants

AND UPON the Claimants undertaking:

- (i) to lift forthwith any exclusion from the Idara-e-Jaaferiya Mosque and Community Centre at 18 Church Lane, London SW17 9PP ('the Mosque') currently imposed upon the Defendants subject to the penal order;
- (ii) to reinstate forthwith to membership any of the Defendants subject to the penal order who are currently expelled from membership of the Idara-e-Jaaferiya;

- (b) either himself or through or with any other(s) to encourage or to assist anyone else to engage in any act described in (a) above.
- (c) either himself or with any other(s) to engage in any disorderly conduct at or within 30 meters of the Mosque.
- (d) either himself or through or with any other(s) to encourage or to assist anyone else to engage in any act described in (c) above.

IT IS ORDERED THAT

1. The claim do stand struck out.
2. Save as provided above, the undertakings given to and injunction made by HHJ Seymour QC on 31 March 2014 are hereby discharged.
3. There be no order as to costs of this action save that the Claimants shall pay the Defendants subject to the penal order the costs of the Applications dated 21 January 2016 and 12 February 2016 in the agreed sum of £8000, payable by 18 March 2016.
4. There be liberty to apply on 28 days' notice in writing by any party.
